**Policy Number:** 102.210  
**Title:** Parity for Female Offenders  
**Effective Date:** 3/17/20

---

**PURPOSE:** To ensure the range of gender-specific services for female offenders exists in all communities of Minnesota and such services are substantially equivalent to the programming offered to male persons charged with or convicted of crimes or delinquencies.

**APPLICABILITY:** Department-wide; Community Corrections Act (CCA) counties; and non-CCA counties

**DEFINITIONS:** None

**PROCEDURES:**

- A. The department ensures that programs for female offenders have a range and quality substantially equivalent to programming offered male persons charged with or convicted of crimes or delinquencies.
- B. Procedures are implemented to ensure the department:
  - 1. Provides leadership, direction, and staff services to the Minnesota Department of Corrections Advisory Task Force on Justice Involved Women and Girls;
  - 2. Is a resource to those working with female offenders in the community and for juvenile female offenders committed to the department of corrections (DOC);
  - 3. Makes certain that model programming and investment initiative grant money appropriated by the legislature is fairly distributed and carefully monitored; and
  - 4. Provides advocacy, information, and education about the needs of female offenders in an effort to ensure solutions and parity.
- C. Task force meeting minutes are distributed to all task force members and are published on the Advisory Task Force on Justice Involved Women and Girls extranet site.
- D. The strategic priorities executive summary is prepared by the DOC task force chair and submitted to the commissioner of corrections. Strategic priorities are published on the Advisory Task Force on Justice Involved Women and Girls extranet site.
- E. A gender-responsive curriculum list is developed by the task force and published on the Advisory Task Force on Justice Involved Women and Girls extranet site.
