The individual shall remain under the authority of the Minnesota Department of Corrections subject to the following standard conditions of release.

STANDARD CONDITIONS OF RELEASE

1. The individual must maintain contact with the agent/designee as directed and comply with all agent directives and instructions. The individual must remain in the State of Minnesota unless granted written approval from the agent/designee, and the individual must keep the agent informed of his or her residence and activities.
2. The individual must submit to any unannounced visits or searches by the agent/designee of the individual's person, residence, possessions, cell phone, computer, vehicle, or premises. The individual must comply with all drug or alcohol testing as directed by the agent/designee.
3. The individual must refrain from purchasing, possessing, accessing, or controlling any type of firearm, ammunition, or dangerous weapon, including replica weapons. The individual must not be found in the presence of a firearm, including those found in a vehicle where the individual is also present.
4. The individual must remain law abiding and refrain from engaging in any behavior that violates local, state, or federal law. Any credible evidence demonstrating that an individual has been charged with a violation of law is considered grounds to hold the individual in custody unless and until the individual is found not guilty. The individual must inform the agent/designee within 24 hours of any court appearance or contact with law enforcement.
5. The individual must refrain from engaging in any assaultive, abusive, violent, harassing, stalking, or threatening behavior, or other behavior that poses a risk to the public.
6. The individual must refrain from direct or indirect contact with any person deemed to be a victim by the Department of Corrections, any person listed in a criminal justice agency report as a victim, or anyone whom a court has determined is in need of protection as demonstrated by a current or previous order for protection, harassment restraining order, or domestic abuse no contact order, without prior documented approval of the agent/designee. The individual must refrain from the use or possession of any technological device, internet site, or internet application for the purpose of monitoring, harassing, stalking, or causing fear in others.

A request to restructure the conditions of release contained herein must be submitted in writing by the releasee to the agent/designee.

The Executive Officer of Hearings and Release or designee will have the final authority to grant or deny restructuring of the conditions of release and any such changes will be set forth in writing.
